"Our company trains fine-tunes of state-of-the-art open source models which will likely not be open sourced due to SB 1047's model liability, directly hurting our competitiveness. We are already considering using Chinese models (which have eclipsed open-source American models already) and will be forced to do so if companies like Meta and Mistral cannot release their models due to SB 1047." *Jeremy Nixon, CEO, Onmiscience*
